NOTICE is hereby given that the Fulton Town Council will hold a Regular Meeting on Wednesday, June 22, 2022, at 7:00 p.m. at the Fulton Town Council Chambers, 201 North Seventh Street, Fulton, Texas. The following subjects will be discussed to wit:

Written comments received by submission to the City Secretary in person or emailed to citysec@fultontexas.org by 4:00 p.m. on the day of the meeting, on any subject matter that is not on the agenda, will be read and summarized in the minutes of the meeting. Persons wishing to address the Council and who have registered using the Speaker’s Card will have up to two (2) minutes to speak. In accordance with the Open Meetings Act, Council may not discuss or take action on any item that has not been posted on the agenda. While civil public criticism is not prohibited; disorderly conduct or disturbance of the peace as prohibited by law shall be cause for the chair to terminate the offender’s time to speak.”

- a. Homestead – If a homeowner already has a homestead exemption on their property, they do not need to re-apply for the Fulton homestead exemption. The exemption will automatically be applied to their property.
- b. Advertisement for Bids have been published for the Prairie Road Drain Pipe project and the CDBG-DR Contract 20-065-054-C164 Streets and Drainage Improvement project. The bid openings will be completed by mid-July.
